# Memorandum

The Governance and Policy Committee is currently reviewing Board Policy #3, which outlines parameters for planning grants, and recommended that the Regional Council Committee review this analysis to inform its perspective on regional engagement and planning grant development. The Department of Housing and Community Development (DHCD) has completed a Planning Grant Impact Analysis evaluating the outcomes of 115 planning grants awarded since 2018, with a focus on their success in transitioning into implementation projects.

At the request of the Governance and Policy Committee, this study is shared with the Regional Council Committee for awareness and discussion. The report outlines the overall success, identifies examples of grants that led to implementation (both within and outside the GO Virginia network), and offers recommendations to for future decision making. Committee members are encouraged to review the materials in advance of the meeting, as they will help frame a broader discussion about regional planning effectiveness and resource allocation.

# Memorandum

#### **BACKGROUND:**

As part of the 2023 JLARC Report regarding the GO Virginia Program, the Commission adopted a series of recommendations. Specifically, recommendation 16 recommended that the Board amend its policy on planning grant caps by modifying the total amount allowed for planning efforts from the current cap of \$250,000 a year for all regions and adjust the maximum amount for an individual planning grant from the current cap of \$100,000.

The specific language of recommendation #16 reads as follows:

"The GO Virginia board should revise its policies to allow regions to award up to 25 percent of their annually allocated per capita funds for planning grants and raise or eliminate the \$100,000 per grant limit.

The GO Virginia State Board initially adopted Board Policy #3 in 2018, establishing two rules regarding use of regional per capita allocations for planning grants. First, the Board limited the amount of resources that any Region could allocate in a single fiscal year for planning to \$250,000. It was envisioned that a small subset of the Regional allocations could be utilized as a pipeline development tool for future implementation projects while also keeping a majority of the regional funds focused on implementation efforts. The second was to limit the amount of state funds that an applicant could request for a single planning effort to \$100,000. Board Policy #3 can be found attached to this memorandum.

As part of the review process for this JLARC recommendation, DHCD staff intends, with guidance from the Committee, to review planning grants that have been awarded through GO Virginia, and determine if these efforts have had a meaningful impact on achieving future implementation projects. Since program inception, there have been 115 planning grants awarded for a total of \$8,969,002. When reviewing these awards, there are a number of variables to consider as part of this analysis:

- 1) What is the reasonable amount of time between a planning effort and the lead into an implementation effort?
- 2) Is it reasonable to account for potential future implementation projects based on GO Virginia planning grants (e.g. a planning grant that was completed in 2022 that has an implementation application and effort in incubation for a potential 2025 implementation)?
- 3) Should planning effort to implementation pipelines be implied (e.g. data from a planning grant report were utilized in another effort) or direct (e.g. a specific recommendation from a planning effort is addressed with a follow-up implementation application)?
- 4) Is it appropriate to account for implementation projects that are directly connected to a GO Virginia planning grant but that are implemented via another source (e.g. a planning grant leading to a successful application to a Federal or other State program)?

### **Staff Recommendation:**

Staff recommends developing a specific survey for the GO Virginia Regional Council's support organizations to complete in partnership with their past subgrantees. The recommended format of the survey could include the following:

- 1) A list of GO Virginia Planning efforts awarded to the Region that is limited to those projects that have closed no later than 2023 with notes of implementation efforts that were awarded by GO Virginia.
- 2) A solicitation to confirm whether any of the listed projects have led to implementation projects directly connected to a planning grant recommendation that was funded through programs outside of GO Virginia (e.g. awards from Federal or State programs or implementations funded through private fundraising means).
- 3) A solicitation to determine if there are any implementation applications directly connected to a recommendation from a closed planning effort that are in the regional pipelines that the supporting organization anticipates submitting for State Board approval in the next 12 months.

Staff would launch the survey over the course of the next several months and return to the Committee at the Summer meeting to share results and a recommended course of action to consider.



## **GO Virginia Planning Grant Analysis**

### Overview:

The Department of Housing and Community Development was tasked with conducting a comprehensive study to analyze the impact of Enhanced Capacity Building (ECB) Grants or Planning Grants as they are referred to in this study. Planning grants are designed to foster economic development by empowering organizations to build their capacity for implementing impactful projects. As part of this effort, DHCD reviewed 115 GO Virginia planning grants for this study. This review aims to assess the tangible outcomes of these projects and determine whether any have successfully transitioned into full-scale implementation projects within the GO Virginia framework.

In addition to evaluating outcomes within the GO Virginia funding sources the study also considers the broader economic effects of these grants, including any benefits that extend beyond the program itself. By examining these projects in detail, the study will provide valuable insights into the overall effectiveness of the planning grants in fostering economic development and collaboration across each region.

The impact of a project is assessed by determining whether a planning grant successfully led to an implementation project, either within the GO Virginia program or externally. This evaluation examines a range of factors, focusing on three primary areas: financial outcomes, comprehensive market analyses, and additional pertinent results that may arise from the planning grants. Specifically, it evaluates the fiscal impacts of these grants on project sustainability, reviews the regional market information collected, assesses the stakeholder engagement that could influence implementation success, and explores any correlated results or insights that may emerge during the planning and execution phases.

The findings from these planning grants are classified into two primary categories: 1) those that have resulted in tangible future project impacts, and 2), those that have not yet yielded any significant project outcomes. It is important to note that some GO Virginia planning grants have explicitly recommended against advancing specific projects. These decisions are acknowledged as a meaningful form of project impact, reflecting a deliberate decision to halt progress and redirect resources, which can ultimately lead to more effective planning and project selection in the future. This comprehensive approach helps ensure that the planning process contributes positively to economic development and community needs.

### Study Parameters and Exclusions:

This analysis presents the most accurate estimates and projections of the outcomes related to the planning grants based on currently available data. DHCD acknowledges data limitations and/or unavailable information at the time this study was conducted. Due to these constraints, the



findings are based on the information that could be gathered, which may not encompass the full scope of the situation. Furthermore, it is essential to note that this research specifically excludes any planning grants that were still underway and have not yet been completed by the time this study was finalized. This limitation may impact on the overall understanding of the effectiveness and reach of the planning grants.

## Study Results:

Based on comprehensive insights gathered from the DHCD and valuable contributions from various supporting organizations involved in the study, we can determine that 29 out of 115 planning grants have successfully led to the initiation of tangible project impact on GO Virginia implementation projects. This results in an overall success rate of approximately 25% across all regions participating in the GO Virginia program since the program's inception.

Four specific regions demonstrate a significant relationship between the number of planning grants awarded to each region and the subsequent project impacts achieved. These regions exhibited highly successful outcomes, with success rates exceeding 44% in generating meaningful impacts from planning grants. Additionally, these regions generally developed more planning grants compared to others. The regions with a success rate below forty percent typically also have lower developed planning grants.

Since 2018, GO Virginia has averaged approximately four planning grants annually that have tangibly created future project impact. There is a consistent yearly baseline for planning grants that generate future project impact. This consistent baseline includes eight projects from four separate regions, which were directly delayed or abandoned due to the COVID-19 outbreak.

### Impact Beyond GO Virginia:

Over the years, many of these planning grants have facilitated additional development of initiatives outside the GO Virginia program. Support Organizations identified an additional 12 planning grants that have successfully transitioned into implementation projects outside the GO Virginia program. This impact was measured through obtaining federal grant funding, attracting private support, or the project was able to expand into an implementation project on its own. This discovery brings the overall total of planning grants that have generated significant future project impacts to 41. Consequently, increasing the percentage of planning grants successfully resulted in implementation projects to 36%.

## Conclusion and Recommendation

The Department of Housing and Community Development (DHCD) conducted a comprehensive evaluation of 115 planning grants to assess their outcomes and determine how many successfully transitioned into full-scale implementation projects—either through GO Virginia or other funding sources. The study focused on financial impacts, market alignment, and other meaningful outcomes stemming from these planning efforts.



Since 2018, 29 of the reviewed planning grants led to implementation projects supported by GO Virginia, representing a success rate of 25%. Notably, four regions demonstrated particularly strong performance, with success rates exceeding 44%. An additional 12 planning grants resulted in implementation projects outside of GO Virginia, bringing the total number of impactful grants to 41. On average, four planning grants per year have led to measurable follow-on activity.

Based on these findings, DHCD recommends that the GO Virginia program refrain from increasing planning grant funding thresholds at this time. While planning grants have supported meaningful work in several regions, the overall conversion rate does not currently justify expanding either the total allocation or the maximum award amount for these grants.

To improve the impact and effectiveness of future planning grants, the study recommends a focused review of the current process—including project development, internal review procedures, and broader program goals. With strategic refinements in these areas, planning grants can better serve as a reliable pipeline for high-quality implementation projects aligned with the economic development priorities of the Commonwealth.

By applying the lessons learned from this evaluation, GO Virginia has an opportunity to strengthen its approach and ensure that planning grants continue to serve as a catalyst for innovation, collaboration, and sustainable regional growth.
